FOOD GRADE CERTIFICATES HAVE TO BE PROVIDED ALONG WITH EACH CONSIGNMENT OF ALL THE MATERIALS USED ALONG WITH THE CERTIFICATES OF TESTS CARRIED OUT DURING PRODUCTION. PACKING SHOULD BE UNIFORM WITH PROPER LEVELING. FINISHED GOODS SHOULD NOT HAVE ANY STICKINESS.

Rate should be quoted per piece basis at F.O.R. Bishnupur price basis (including all). GST %, HSN code of material etc should be mentioned clearly in the quotation. Price break up is to be given.

Within 15 days after acceptance of the material in good condition & duly certified by the concern person/persons at Bishnupur Dairy Plant.
