

condition and in case of any breakage of seal and/ or mishandling of chilled milk during transportation will be liable to the concern.

Payment will be made against monthly bill basis, within 15 days (may be vary depend on the situation) from the date of submit the bills.

9. GENERAL INSTRUCTION FOR FILLING OF TENDER FORM:

- i) No scribbling is permissible in the tender document and no special conditions to be stipulated by the tenderer in the same. If the tenderer wants to intimate anything of importance he may so in the stipulated sheet. Such stipulation and conditions may be considered to be a part of the contract to such extent only as may be explicitly accepted by the authority and communicated to the successful tenderer. The authority however, reserves the right not to accept any such special stipulations and conditions made by the tenderers and may ask the tenderer to withdraw any or all such stipulation before the contact agreement. 17. EXECUTION OF WORK ECONOMICALLY:


