Terms & Condition

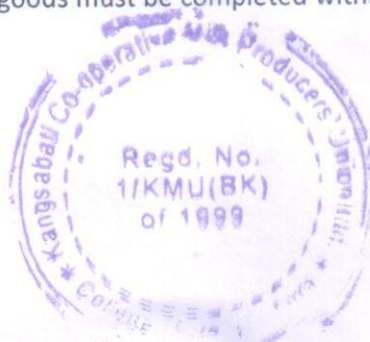
1. The copies of all relevant documents as mentioned above must be sent physically / through post to the office of The Kangsaboti Cooperative Milk Producers' Union Ltd in sealed envelope cover so as to reach this office before last date and time of submission.

2. The intending bidder is required to quote the rate in figures as well as in words. Rate should be quoted per kg of item.

3. Payment will be made on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority.

4. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. Kangsaboti Cooperative Milk Producers' Union Ltd. Reserves the right to cancel the Tender at any time without showing any reason in the interest of the public and no claim in this respect will be entertained.

5. Supply of Goods: The supply of goods must be completed within 10 days from the date of issue of Purchase Order.



6. Place of Delivery: The office of Bishnupur Dairy Plant, Turki, Bishnupur, Bankura, Pin-722122, West Bengal.

7. Before issuance of the PURCHASE ORDER, the tender inviting authority may verify the original credential(s) and/ or other document(s) of the lowest bidder with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest bidder is/are either manufactured or false, the work order will not be issued in favour of the said Bidder.

8. Conditional and incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender.

9. The accepting authority (Kangsaboti Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders. In case the accepting Authority observes that the L1 bidder will not be able to supply all the materials in time, then the accepting authority reserves the right to split up offer to L2, L3 and others on L1 price for completion of time bound programme.

10. The rate quoted by the bidder shall be inclusive of all taxes and other charges/ taxes if any for the delivery of the goods in the office of Bishnupur Dairy Plant, Turki, Bishnupur, Bankura, Pin-722122, West Bengal.

11. Mode of transportation for the supply of the goods will be arranged from bidder side.

12. Bids shall remain valid for a period 180 days. If the price of Skimmed Milk Powder is decreasing in the market than the purchase price, then it may be purchase from the selected bidder at the lower price.
